## **BRENTWOOD SCHOOL CONDUCT POLICY**

The Brentwood School community expects and requires all its members to behave honorably and civilly at all school-related activities, both on and off campus. Conduct of a student, parent, or other school representative at any school-related activity reflects not only on the actor but also on the school community as a whole. Failure to behave honorably and civilly while at school or at any school-related activity may result in discipline up to and including expulsion from the school community.

The school generally will not address off-campus misconduct that does not directly affect the school, but it reserves the right to get involved and even to impose discipline for such misconduct in appropriate cases. For example, the school may address off-campus or digital misconduct that affects the health or safety of a student or other member of our school community. Such misconduct might include, but is not limited to, harassment, bullying, illegal alcohol or drug use, or the illegal provision of alcohol or drugs by students or parents. Similarly, the school may choose to respond to off-campus misconduct that might negatively affect the school's reputation, such as misbehavior in the Brentwood Village. In sum, for any reason the school considers sufficient in its sole discretion, the school has the right to decline enrollment or re-enrollment or to discipline, suspend, or dismiss any student. The fact that the school reserves the right to address off-campus misconduct that does not directly affect the school shall not be construed to create any duty to address such misconduct, and the school, in its sole discretion, may elect to refrain even when asked to respond to misconduct that does not directly affect the school.

Parents and students are expected to review the Family Handbook, which sets forth various school policies, including those pertaining to use of the school's network and computers, alcohol and substance abuse, harassment, and specific behavior rules for the Lower School, Middle School, and Upper School.

By signing the school's Enrollment Agreement, parents affirm their acceptance of the school's policies, rules, and regulations and acknowledge the school's sole and complete discretion to determine the appropriate response to parent or student behavior that violates the school's core values or policies, which response may or may not include student discipline or non-renewal or termination of the Enrollment Agreement.

# Transportation Program Overview

---

Brentwood School is located in a residential community, and we care about being good community partners. An important commitment we made in our 2017 Conditional Use Permit (CUP) and agreements with our neighbors was to dramatically decrease traffic to and from school even with increased enrollment. To achieve this, we rely on each and every household to do what they can to reduce vehicle trips to both campuses, especially by taking the bus.

To demonstrate compliance, we are required to maintain at least 40% daily bus ridership and carefully monitor the number of vehicles entering the campus between 7:30 and 9 a.m. and between 3 and 7 p.m. An automated traffic monitoring unit counts cars continuously throughout the day to ensure that we are within our limit, and there are increasingly stiff penalties if we are not. It is important to understand that we are successful only if everyone at Brentwood School follows the transportation rules we have in place.

We offer a range of transportation options that comply with the parameters Brentwood School committed to in our Conditional Use Permit (CUP) and neighborhood agreements (outlined below). We expect all families at Brentwood School to utilize the options available and to model our Core Values by respecting the rules.

# Summary of Policies

---

## EAST CAMPUS

### ***Explicitly Prohibited in our CUP***

Drop off or pick up in the surrounding neighborhood (including Brentwood Village, Veterans Barrington Park, and the Post Office) at any time of day.

### ***Preferred Mode of Transportation***

Bus. On a daily basis, at least 40% of Brentwood students need to ride the bus.

### ***Student-Driven Carpool Rules***

A student driver plus three (3) Brentwood School East Campus students constitutes a complete carpool.

Student Drivers must pay a parking fee of \$750 and be fully licensed with a complete carpool.

### ***Parent-Driven Carpool Rules***

Parent/Guardian driver plus three (3) Brentwood School East Campus students constitutes a complete carpool.

## WEST CAMPUS

### ***Preferred Mode of Transportation***

Bus. On a daily basis, at least 40% of Brentwood students need to ride the bus.

### ***Parent-Driven Carpool Rules***

Parent/guardian plus two (2) West Campus students constitutes a complete carpool. No parking or waiting in the residential neighborhood adjacent to the West Campus.

West Campus bus routes offer communal pick-up/drop-off locations. You will be contacted by the school once the routes have been formed based on sign-ups. Please note that specific route stops are subject to change.

## WALKING & BIKING

We strongly encourage our families who live a short distance from the West Campus to walk or bike to school. Besides the many physical, emotional, and environmental benefits gained from walking, your contribution to lower the traffic around the West Campus directly benefits our community.

If you live nearby and want to consider walking or biking to school, you can use our [online directory in Eagle Eye](#) to locate other families near you and walk together. Please note that students walking or biking to school will still need to complete the West Campus Transportation Plan online.

## Walking Safety Tips

- Walk on sidewalks and in crosswalks whenever possible.
- Look left, then right, then left again, before you step into the street. Be careful of blind spots around cars, trucks, and buses when walking near or around them; always assume the driver does not know you are there.
- Use caution when crossing intersections and streets; you may think vehicles will stop for you, but they may not see you and may not be able to stop in time.
- Before entering the street, make eye contact with any drivers stopped at the corner.
- Make yourself visible.

## Biking Safety Tips

- Helmets are required by law for any bicyclist under the age of 18
- Bicycle riders must obey all stop signs, traffic signals, and other traffic signs
- Always ride with traffic
- Always remember to give pedestrians the right of way
- Be visible, alert, and communicate your intentions
- Review the CA Vehicle Code regarding the operation of bicycles

## CARPOOL

If your child is not riding the bus or walking to and from school, it is very important they be in a carpool with other West Campus students in order for the school to meet our Conditional Use Permit mandates regarding carpool ridership levels. Driving to and from campus without the minimum of two West Campus students in your carpool, during peak hours, is not acceptable.

Unfortunately, the Conditional Use Permit does not recognize students who attend other schools or our East Campus as qualified members of the carpool. However, if you have a complete West Campus carpool and also have an East Campus child, you may sign your East Campus child up for bus route 713 and drop them off on the West Campus. They may then get on route 713 at the Sunset/Saltair stop to travel to the East Campus. Route 713 stops at Sunset and Saltair at 8:10 a.m. and arrives in time for the 8:30 a.m. start on the East Campus. The afternoon bus leaves the East Campus at 3:35 p.m. There is a crossing guard present. Please keep in mind that EC students who

use this option do not count toward the WC carpool total. Please contact the Transportation Manager at [mobility@bwscampus.com](mailto:mobility@bwscampus.com) for more information about this option.

The Brentwood School Public Safety Department will verify carpools during morning drop-off throughout the school year.

### ***Carpool Procedures***

Kindergarten families have a different schedule for the first few days. Please make the necessary arrangements if your carpool includes a Kindergarten child.

Punctuality is important! Please make certain that you allow enough time in the morning so children arrive before the morning gathering at the flagpole (8:15 a.m.). Students arriving after 8:15 a.m. are considered tardy. Drop-offs also need to be staggered. If everyone arrives between 8:05 a.m. and 8:15 a.m. we will have to assign drop-off times to ease the impact on the neighborhood streets.

If you need to park during the morning drop-off, please drop your child off first and then go into the garage and park. For safety reasons, we cannot permit parking in the Bundy outdoor lot during the morning drop-off.

Please DO NOT arrive before 3:20 p.m. for the afternoon pick-up. Parking or waiting on the neighborhood streets or in the driveway is **not** permitted.

Arriving between 3:20 p.m. and 3:40 p.m. on Monday-Thursday or between 2:20 p.m. and 2:40 p.m. on Fridays means less time waiting in line.

The drop-off and pick-up route stipulates that you enter the driveway by making a left-hand turn from Bundy. You may NOT turn off Sunset directly into our driveway nor may you turn right heading north on Bundy. Please make certain you follow the drop-off and pick-up route between the hours of 7:30 a.m. and 6:30 p.m.

Please remember that your watch or clock may vary from the "official time." We realize that this can be a major source of aggravation, especially when you believe you have arrived on time, but the only way we can be consistent is to follow the school's time.

Please display your carpool sign in the window of your car every day. Signs not only identify the pick-up groups, but also allow us to announce your arrival so your group can be ready and waiting. If you do not display your carpool sign in the window you will not be allowed to enter the carpool pick-up line. You will be directed back out to Bundy and will be in the last group allowed to pick up students. Bus riding families should also request a card if you anticipate picking up your child during the year. If you need extra signs for a nanny or other regular drivers, please contact the Lower School office.

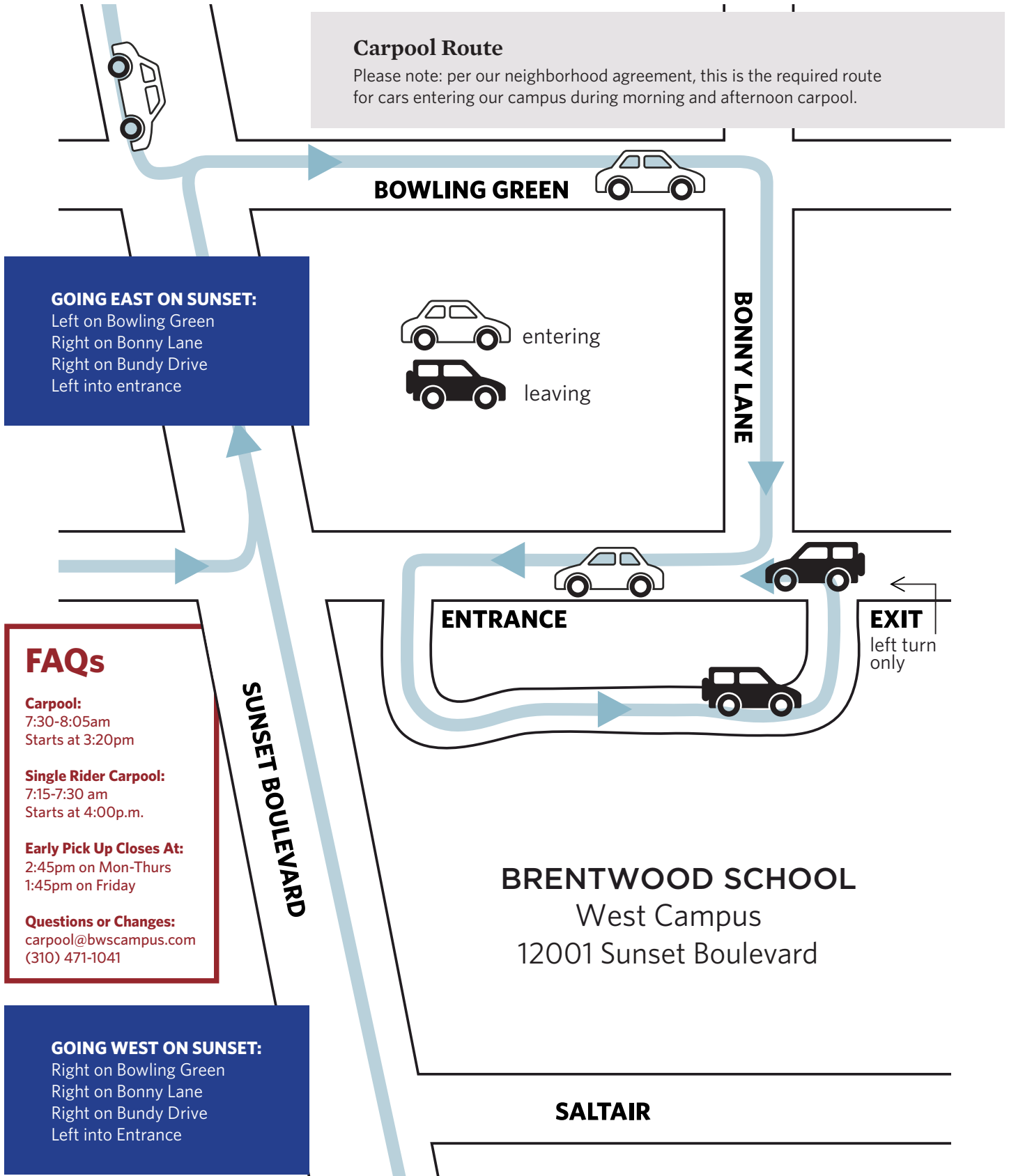
Students should be informed of their assigned carpool drivers or any changes in carpool plans. It makes for a smoother afternoon pick-up if students are ready to respond when it is time to leave. Please remember to notify the school in writing (at [carpool@bwscampus.com](mailto:carpool@bwscampus.com)) before 11 a.m. Monday-Friday of any playdates, sporting events, etc. which would change the carpool.

As a general rule, we do not allow rideshare companies to pick up students from the West Campus.

Saltair access is not available.

Students who are dropped off in violation of these rules will be subject to disciplinary action.

# East Campus Transportation

We appreciate your understanding of the special conditions that restrict traffic, campus access, and parking at Brentwood School. Thank you for helping us continue to be a good neighbor. Please contact us if you want support in brainstorming a plan that works for your family.

**Explicitly prohibited in our CUP:** Drop off or pick up in the surrounding neighborhood, including Brentwood Village, Veterans Barrington Park, and the Post Office at any time of day. Also prohibited is parking/waiting in the Veteran Parking Lot for any purpose related to school.

## BUS PROGRAM - FREE!

Flexible bus scheduling by day, trip, and time supports us in fulfilling our obligation of 40% daily ridership! You can create a customized plan by route, day of the week, time of day, and direction of service. As part of each student's transportation plan, you will have the option to sign up for the bus if you expect to use it on a regular basis. If you do not sign up for the bus, your child may still use the day pass option. While there is no fee for either daily or occasional use, it will be critical to reserve a space when and if riding the bus.

## Spend Less Time in Traffic

By dropping off and/or picking up at a bus stop away from school, you can spend a lot less time in traffic. Sign your student up to ride the bus in the morning and/or afternoon, and pick up or drop off at the bus stop most convenient for you. NOTE: the "express stops" below indicate the closest stop to the East Campus for each route. We encourage families to drop off/pick up here rather than fighting traffic to campus in the morning and afternoon.

718 - Valley: Express stop at Mulholland/Casiano

719 - West Valley: Express stop at Sepulveda/Moraga

720 - Santa Monica: Express stop at the Brentwood Country Mart

## Cost

There is no additional cost for school bus service.

## Bus 713 Campus-to-Campus Stop

For families with complete West Campus carpools and students on both campuses, bus route 713 can transport East Campus students from the West Campus to the East Campus in the morning, and again from the East Campus to the West Campus in the afternoon (see details in West Campus Carpool section). It stops at Sunset and Saltair at 8:10 a.m. and arrives in time for the 8:30 a.m. start on the East Campus. The afternoon bus leaves the East Campus at 3:35 p.m. There is a crossing guard present. Please keep in mind that EC students who use this option do not count toward the WC carpool total.

## EAST CAMPUS WESTWOOD SHUTTLE

Brentwood School also offers a direct shuttle to and from school. This is a great option if you do not have a full carpool and you need to arrive after 7:25 a.m. Signing up for the shuttle is not required. While there will be no fee for either daily or occasional use, it will be beneficial to indicate if you would like to try out the shuttle in your transportation plan. Please note: use will be monitored and shuttles will be offered at the times listed below. As our shuttle holds a capacity of nine (9) students per departure, if you would like a guaranteed direct transportation, please sign up for one of our school bus options.

## PARENT/GUARDIAN-DRIVEN CARPOOL

**NOTE: We recommend bus ridership as the preferred mode of transportation. Please know that carpooling is a responsibility and not a right. Parents/guardians who choose to carpool agree to accept the responsibility that comes with it. In particular, if for any reason, there is not a complete carpool on any given day, the carpool must arrive before 7:30 a.m. or the riders must take the bus.**

Students entering campus via car between the hours of 7:30 and 9 a.m., as well as between 3 and 7 p.m., must be part of a complete carpool, whether driven by a parent/guardian or a student. A complete parent/guardian driven carpool consists of a minimum of three (3) East Campus students in the morning and in the afternoon.

Note: If a situation arises in which a carpool rider or driver will not be present, it is the primary driver's responsibility to get their remaining carpool to school before 7:30 a.m., find a replacement to drive or complete the carpool, or make sure the remaining riders take the bus.

Parent/guardian drivers have the following parameters for drop-off in the morning:

- Drive to school with at least three (3) Brentwood School East Campus students in the car
- Find a replacement driver if absent
- Drop off incomplete carpools on campus by 7:25 a.m.
- Drop off incomplete carpools at one of the closest bus stops to the East Campus (see "bus program" above)

Parent/guardian drivers will have the following options for pick-up in the afternoon:

- Pick up at least three (3) Brentwood East Campus students
- Pick up incomplete carpools at one of the closest bus stops to the East Campus (see "bus program" above)

**NOT ALLOWED:** Drop off or pick up in the surrounding neighborhood, including Brentwood Village, Veterans Barrington Park, and the Post Office at any time of day. Also prohibited is parking/waiting in the Veteran Parking Lot for any purpose related to school.

## ***Important Information for Parent/Guardian Drivers***

The Brentwood School Public Safety Department will monitor carpools during morning drop-off.

Students may not be dropped off or picked up curbside on Barrington Place or along any of the nearby streets between San Vicente Blvd. and Sunset Blvd., including Brentwood Village, Dog Park, Post Office, the Brentwood Village (VA) parking lot, or Barrington Rec Center — this is expressly prohibited in our CUP and neighborhood agreements.

If a student wants to purchase something from a local shop, they must walk to the Village from school. This applies in the morning as well as the afternoon. Students walking on or off campus must follow the newly established crosswalk pattern (diagram on page 12) which no longer allows use of the southernmost crosswalk at Barrington Place and Chayote (near Kreation) in order to prevent students from crossing the driveway access to Brentwood School. Pedestrian crossing will no longer be permitted across the vehicular entrance and exit to the school.

Parents/guardians are expected to model our core values. Those who park in the emergency lane, drop off/pick up curbside or in the traffic lane, cut through the Brentwood Village (VA) parking lot, drive recklessly, fail to follow the directions of the parking monitors, or are disrespectful, are subject to consequences ranging from verbal or written warnings to, in the most extreme cases, removal from the community. These rules will be strictly monitored and enforced. Nothing damages our relationship with the neighbors and the City of Los Angeles more than violating this rule.

Additionally, rideshare services (Uber, Lyft, etc.) are not allowed to enter the Brentwood School campus. Students using a rideshare service must be 18 years of age (Uber) or 17 years of age (Lyft) unless accompanied by a parent/guardian.

### ***The Breakfast Club***

Join "The Breakfast Club!" We offer FREE breakfast vouchers to all fully-compliant student- and parent/guardian-driven carpools entering the East Campus by 7:25 a.m. Every student in the car will receive a voucher to be used in the Middle and Upper School Cafeterias that morning for breakfast.

## **Request for Extreme Hardship Exceptions**

We understand there may be the rare instance in which a family has a unique circumstance that makes it impossible to organize transportation. We encourage you to contact the Transportation Team to discuss ideas and options. If you need to apply for an extreme hardship exception, please submit the Transportation Extreme Hardship Exception Form.

## **PUBLIC TRANSPORTATION**

### **Riding Big Blue Bus and LA Metro Rail or Bus**

Brentwood School can be reached via Big Blue Bus Route 15, which connects to LA Metro's Expo Line at the Expo/Bundy Station (located on Exposition Blvd. and Bundy Dr.). The closest stop to Brentwood School is at the end of the line, on Barrington Place and Chayote Street. Brentwood School can also be reached by taking LA Metro Bus Route 602 on Sunset Blvd. from PCH to Westwood. The closest Line 602 stop to campus is at the corner of Sunset Blvd. and Barrington Ave.

### **How to Ride the Big Blue Bus: App it!**

Whether you're an advance planner or like the excitement of traveling on a whim, having smart technology at your fingertips makes it easy to get going. With these trip-planning apps, your mobile phone is set to provide real-time transit directions for bus, train, bike, and travel by foot. Your next adventure is just a download away.

- **Transit App** — Transit is user-friendly platform for planning routes and checking current departure times for nearby transit
- **Google Maps** — Google your way around town with easy-to-get transit directions for bus, train, bike, and travel by foot
- **NextBus** — Through NextBus, Big Blue Bus and Metro Bus offer riders real-time bus arrival predictions and bus vehicle locations through its easy-to-use apps

### **Paying Your Fare**

Big Blue Bus offers a \$19 30-Day Youth Pass (ages 5-18) providing unlimited rides (any line, any time) during a consecutive 30-day period. LA Metro offers a reduced-fare Student TAP Card that lets you enjoy limitless rides on all LA Metro trains and buses for \$24 a month.

## **How to Get a Student TAP Card**

To apply for the Student TAP card you'll need to fill out and submit a Student TAP Card Application and provide proof of enrollment with one of the following documents:

- Current report card; OR
- Current valid school ID; OR
- Class schedule with the total number of units and/or in-classroom hours; OR
- Official letter from school verifying enrollment

### **Interagency Transfers on TAP**

Save money with a TAP card. Students can transfer from Big Blue Bus to LA Metro (or vice versa) for just \$0.50. First, make sure you have a TAP Card loaded with Stored Value in order to transfer. Here's how it works:

- Get a Reduced Fare Student TAP card (details above) or a regular TAP card
- Load Stored Value (works like cash) on your Student TAP card from anywhere TAP cards are sold, Metro Rail Stations, online at [www.taptogo.net](http://www.taptogo.net), or by calling TAP at (866) 827-8646
- Tap your card on your first trip
- When transferring to another agency like LA Metro, tap again and the transfer fare of \$0.50 will be automatically deducted from your TAP card

## **STUDENT-DRIVEN CARPOOL**

**IMPORTANT: Driving or riding in a carpool is a responsibility and not a right. All students who choose to carpool agree to accept the responsibility that comes with it. In particular, if for any reason, the driver is absent and there is not a designated substitute driver, the riders must take the bus.**

### **Fully Licensed Student Drivers**

Synopsis: Parking permits are granted only to Upper School students who have registered a full carpool. Morning and afternoon, a Driver + 3 EC Students is required for a full carpool.

East Campus student parking permits are issued only to senior and junior students who have an unrestricted license (this means they have been licensed for one full year) and a registered carpool of at least three other Brentwood School East Campus students. The following are important details:

- Parking spaces are assigned in the order the permit request is received
- Student drivers are issued parking permits only upon demonstrating proof of a complete carpool
- It is the responsibility of the carpool driver to transport their riders to and from school daily
- If the driver sick and there is no designated substitute driver, the riders must take the bus
- There are enough parking spaces to accommodate all student drivers who have permits
- Student parking is available in both the lower lot and the upper lot
- Student drivers who get their complete carpool to school before 7:25 a.m. receive vouchers for a free breakfast as they are part of the "Breakfast Club" that day
- If a situation arises in which a carpool rider will not be present, it is the student driver's responsibility to get their remaining carpool to school before 7:30 a.m. or find a replacement to complete the carpool in order to park in the lower lot
- If the missing rider **WILL NOT** be coming to campus later that day, or is already on campus for an early practice/rehearsal, the incomplete carpool may enter and park in the upper lot

- o Permission letters from three or more carpool passengers. (Carpool passengers filling out their plan will suffice as a permission letter.)

NOTE: Students may NEVER park on neighborhood streets, Brentwood Village, Dog Park, Post Office, Brentwood Village (VA) parking lot, or Barrington Rec Center.

### ***Dates and Details***

Student parking permits cost \$750 per year (in addition to the transportation fee). We strongly suggest each rider pay \$250 to the driver while the driver maintains fiscal responsibility for the car and fuel. The parking permit application is incorporated into the East Campus Transportation Plan. Applications will be processed in the order in which they are received. Students will not qualify for permits without all supporting documentation on file. Once the Public Safety Department has received the maximum number of student parking applications for the spaces available, students will automatically be waitlisted.

Please note: late applications are only considered if spaces become available.

### ***Drivers Who Qualify Mid-Year***

Students who are not eligible for a parking permit before the start of the school year, but who become eligible during the school year, may apply for a parking permit two weeks prior to becoming eligible (generally, just before the one-year anniversary of the issuance of their first driver's license) assuming they have a complete carpool. Permits will be issued on a first-come, first-serve basis. A parking permit will be issued on or after this one-year mark if space allows and if the student driver will be carrying at least three (3) other Brentwood School East Campus students to and from school for the remainder of the school year.

### ***Handicapped Parking***

If a student who already holds a Brentwood-issued on-campus parking permit is injured or ill for a specified time during the current school year, and has obtained a California DMV-issued handicapped parking placard, a handicapped parking space, if available, will be provided for the prescribed time period indicated in a signed doctor's note addressed to Brentwood School. We have

While we realize that this policy may cause some difficulties, we must comply with our Conditional Use Permit and Covenant or face significant fines. Please understand that students risk losing their parking privileges and receiving other sanctions, including detention, internal suspension, and even expulsion from school if they drive onto campus without a permit, disregard the directions of Public Safety personnel, fail to park in the designated area, drive recklessly, stop or park in the emergency/traffic lane for any period of time, or fail to follow directions of other school employees.

### ***To Apply for an On-Campus Parking Permit:***

- Coordinate a carpool using the [Parent/Guardian Directory in Eagle Eye](#) and form your carpool.
- Submit the Student Driver section of the East Campus Transportation Plan online.

limited handicapped parking available. To be considered for a handicapped space, the student must provide the following:

A state DMV-issued handicapped placard, to be prominently displayed in the student's car at all times OR a doctor's note describing the nature of the illness or injury and related treatment in detail, including approval for the student to operate a motor vehicle while under the doctor's care, as well as the recommended time period for the need for handicapped parking.

Please note: Police officers have the right to verify a handicap placard, should an officer be on-campus.

Students who meet the above criteria must call or visit the Welcome Center to arrange for on-campus handicap parking. A parent/guardian signature is required on the Handicap Parking Request Form, which may be obtained from the Welcome Center. In the event that a Handicap Parking Space is not available, each case will be considered on an individual basis. While we strive to do our best to accommodate student drivers (with Brentwood School permits) who have temporary special parking needs, it may not always be possible to do so.

Because of parking space limitations, and the requirement that only current parking permit holders may obtain handicap parking for a limited time period, all other students with special circumstances must be dropped off ON campus by a parent/guardian, a carpool, or by any means available to the student.

## WALKING AND BIKING

We strongly encourage students who live a short distance from the East Campus to walk or bike to school. Besides the many physical, emotional, and environmental benefits gained from walking and biking, your contribution to lower the traffic around the East Campus directly benefits our community.

If you live nearby and want to consider walking or biking to school, the [Parent/Guardian Directory](#) search can help you find other students within your area to travel to school together. Please note that students walking or biking to school will still need to complete the East Campus Transportation Plan at the button below.

### ***Walking Safety Tips***

- Walk on sidewalks and in crosswalks whenever possible
- Look left, then right, then left again, before you step into the street

- Be careful of blind spots around cars, trucks, and buses when walking near or around them; always assume the driver does not know you are there
- Use caution when crossing intersections and streets; you may think vehicles will stop for you, but they may not see you and may not be able to stop in time
- Before entering the street, make eye contact with any drivers stopped at the corner
- Make yourself visible

Note: Students walking on or off campus must follow the newly established crosswalk pattern (diagram below) which no longer allows use of the southernmost crosswalk at Barrington Place and Chayote (near Kreation) in order to prevent students from crossing the driveway access to Brentwood School. Pedestrian crossing will no longer be permitted across the vehicular entrance and exit to the school.

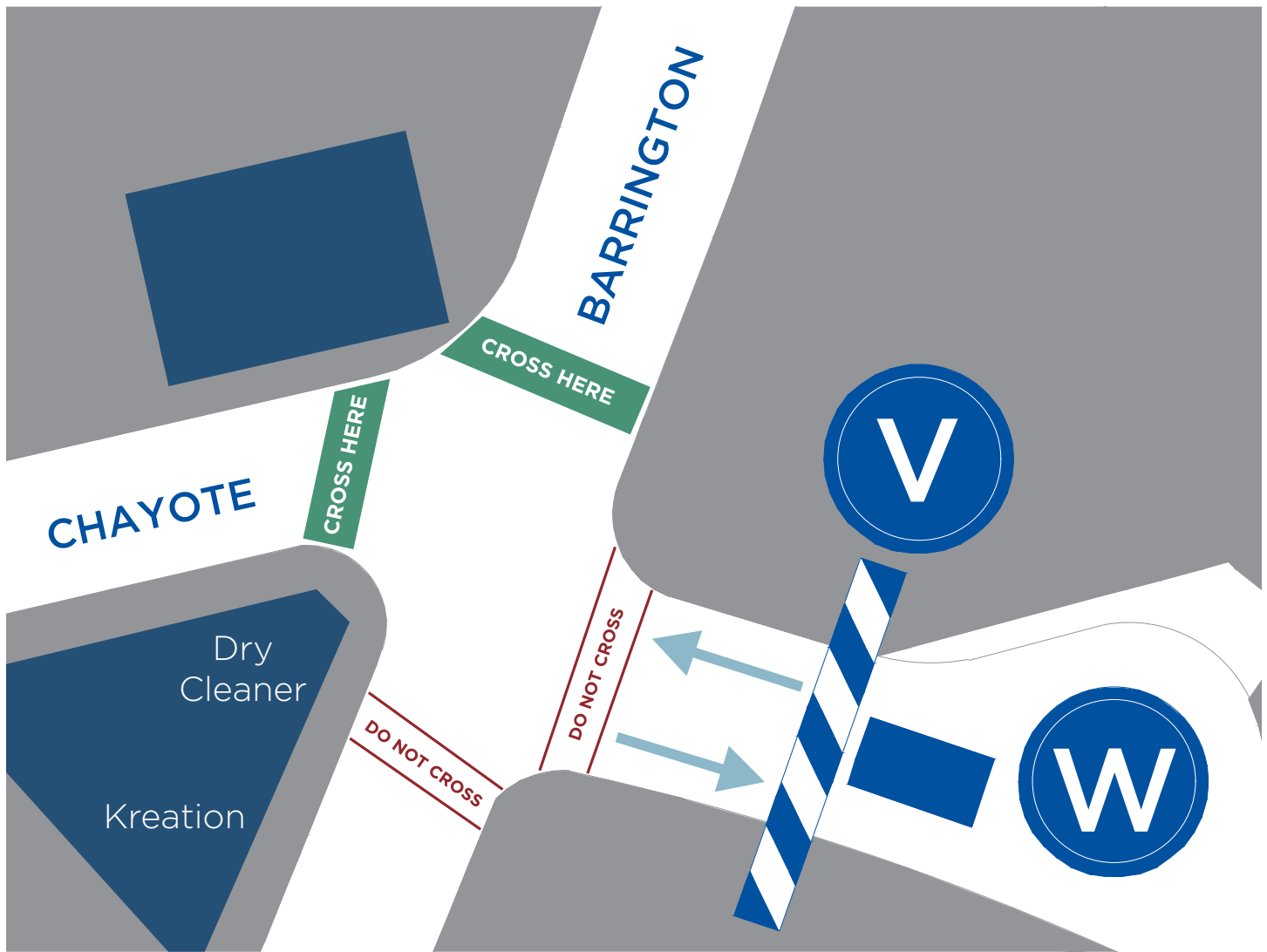
### ***Biking Safety Tips***

- Review the CA Vehicle Code regarding the operation of bicycles

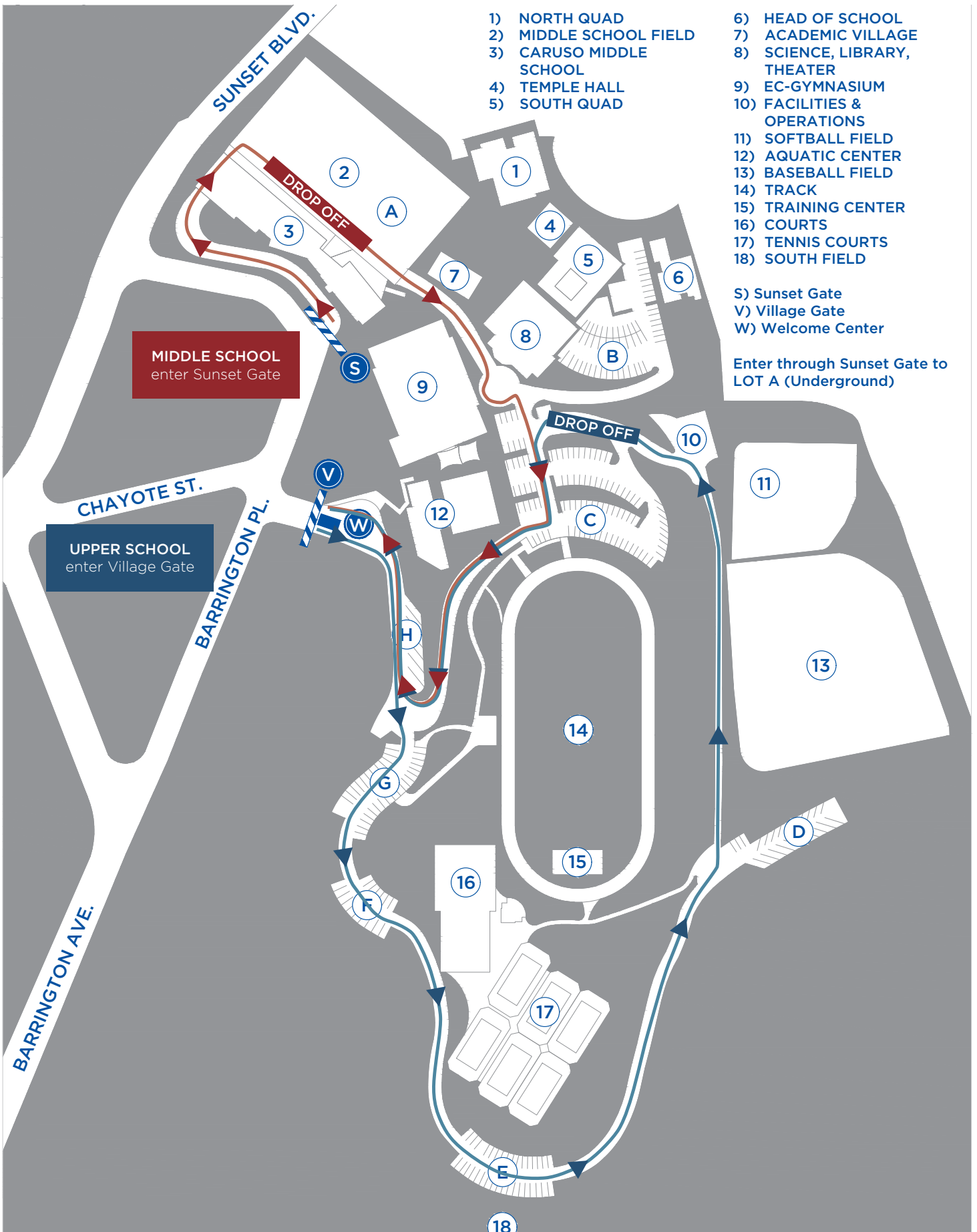
## CONSEQUENCES FOR NON-COMPLIANCE
